The school board election will take place on Tuesday, February 3, 2015. Ms. Muller-Aragon says that she wants to bring a sense of civility, objectivity, and a working knowledge of the classroom to the board. She wants equal access to a quality education for all students. As a parent and retired teacher, she knows that education is a societal equalizer.

District 4—Mark J. Gillboard

Mark J. Gillboard works for Clear Channel Outdoor. He has a bachelor's in rhetoric and Spanish and a master's degree in communication. He and his wife are APS parents with two young daughters that attended Bandelier Elementary School. He's a member of the PTA is a former Rio Grande High School Volleyball coach. Mr. Gillboard is the son of a retired life-long

special education teacher and wants to help shape the future policies and direction of the APS school system.

The Chamber Board voted unanimously in favor of endorsing the slate presented today. The Chamber is encouraging all of its members to vote early or by absentee ballot. Early voting ends January 30. The deadline to request an application for an absentee ballot is January 29.
